Communications can be a powerful tool in public health, but we often find ourselves reacting to a toxic narrative rather than setting forth our own equally powerful, transformational narrative about health. The Wisconsin Healthiest State Initiative, a program organized by the MATCH Group at the UW Population Health

Institute, convened a statewide group to develop a transformative health equity narrative for Wisconsin. This narrative has since been applied to COVID-19 communications from places like local health departments and public health partners and has been observed in Governor Evers' public remarks.
