Forums on the proposed purchases of MyChoice Wisconsin and Inclusa

Two national for profit health insurance corporations have announced proposals to acquire local Family Care Managed Care Organizations (MCOs). **Molina** intends to acquire **MyChoice Wisconsin**. MyChoice Wisconsin has more than 16,800 Family Care members in 39 counties. Molina already owns TMG, Wisconsin's largest IRIS consulting agency with more than 17,600 participants (73 percent of the entire IRIS membership). **Humana** intends to acquire **Inclusa**. Inclusa has more than 15,500 Family Care members in 68 counties. Both Molina and Humana are large scale, for profit, corporations operating in multiple states, and their primary business is health care insurance.

DHS oversees Family Care MCOs and has requirements through its contracts to ensure quality care. DHS's Managed Care Contract **is the state's primary tool to direct how Family Care operates after the acquisitions occur.**

The Wisconsin Department of Health Services (DHS) is hosting online forums December 14 and 15 to hear from stakeholders and the public about the proposed purchases of Inclusa by Humana, Inc. and My Choice Wisconsin by Molina Health Care, Inc. [Learn more about these proposed asset purchases.](#)

The forum will include a brief presentation about the proposed asset purchases and the process DHS is taking to review the transactions with a focus on ensuring uninterrupted services for members. Attendees will then have time to give comments and suggestions to DHS.

The purpose of the Family Caregiver Involvement - Hospital Discharge Survey is to collect Wisconsin family caregiver experiences at the time of a loved one/care recipient's hospital discharge. Greater Wisconsin Agency on Aging Resources, Inc (GWAAR) is collecting this information to learn about caregiver involvement at the time of discharge. The survey will take less than five minutes of your time to complete and will provide valuable information to further advocacy efforts. We have extended the survey until December 15, 2022.

Family Caregiver Involvement - Hospital Discharge Survey

The purpose of this survey is to collect Wisconsin family caregiver experiences at the time of a loved one/care recipient's hospital discharge. Greater Wisconsin Agency on Aging Resources, Inc (GWAAR) is collecting this information to learn about caregiver involvement at the time of discharge. The survey will take less than 5 minutes of your time to complete.

For this survey, a "family caregiver" is defined as any relative, partner, friend, or neighbor who has a significant personal relationship with and provides a broad range of assistance for, an older person or an adult with a chronic or disabling condition. Responses to this survey will be combined with overall results to understand the hospital discharge process in urban cities, rural communities, and elsewhere throughout the state of Wisconsin. The data collected will be shared to promote advocacy efforts within the legislation, administrative rules, and healthcare systems and associations. Information collected will be kept anonymous.

From the Consumer Financial Protection Bureau (CFPB): Beware Debt Collection Activities

There are approximately 48 million family members and friends caring for adults with health or functional needs in the United States, and nearly one in six adults is supporting the health and well-being of an older adult through illness or disability.

Although the Nursing Home Reform Act (NHRA) prevents a nursing home "from requiring a person other than the resident to assume personal responsibility for any cost of the resident's care," some nursing homes and debt collectors do bill or sue residents' family members and friends for the cost of care on the basis of their admission contracts.

...in Consumer Financial Protection Circular 2022-05, the practices of nursing homes and the debt collectors they hire may violate federal laws administered by the CFPB and the Centers for Medicare & Medicaid Services (CMS). The CFPB and CMS have released a joint letter urging nursing homes and debt collectors to examine their practices for compliance with federal law.

If you or a consumer you are working with has experienced this, you can share this information with your State Department of Health and your State Attorney General. You can also submit a complaint to the CFPB if you believe that a debt collector, such as a company or law firm acting on behalf of a nursing home, may be engaging in unlawful debt collection or credit reporting practices.

WI DPI Creates Brain Health Unit

The Wisconsin Department of Public Instruction (DPI) created a new unit designed for Middle and High School Students called “Advocacy for Self and Others: Brain Health”. The new unit is available to middle and high school teachers statewide. Students will learn about brain health, what is normal aging, the effect of music on the brain, concussion and brain injury prevention and awareness, dementia, providing care and the skill of advocacy.
