Four Public Hearings Scheduled by JFC

The Co-Chairs of the Joint Committee on Finance (JFC), Senator Howard Marklein (R-Spring Green) and Representative Mark Born (R-Beaver Dam) announced four public hearings related to the State Budget yesterday.

The public hearing schedule is:

- Wednesday, April 5, 2023 Waukesha County Expo Center, Main Arena 1000 Northview Rd, Waukesha
- Tuesday, April 11, 2023 UW-Eau Claire, Davies Student Center Ojibwe Grand Ballroom (Third Floor) 77 Roosevelt Ave., Eau Claire
- Wednesday, April 12, 2023 Wilderness Resort, Glacier Canyon Conference Center Sandstone Meeting Room 45 Hillman Road, Wisconsin Dells
- Wednesday, April 26, 2023 Lakeland Union High School 9573 State Highway 70, Minocqua

The public hearings will begin at 10 a.m. and conclude at 5 p.m. Attendees will be asked to fill out a form upon arrival to be added to the queue to testify. The JFC has also created an online portal for constituents to provide input. Caregiver Crisis Coalition of Wisconsin 2023-2025 State Budget Recommendations

In the recent years, it has become clear that the biggest threat to the lives of older adults and people with disabilities in Wisconsin who need long-term care services is the Caregiver Crisis: an increasingly acute shortage of caregivers in every sector of the long-term care system. This crisis is impacting every community in Wisconsin, but it is particularly severe in many rural areas.

The Caregiver Crisis Coalition of Wisconsin (of which GWAAR is a member) is calling on the state legislature to take serious action now in this state budget to reverse the ominous trend which is putting more Wisconsin residents at risk every year. Unless the landscape for caregivers improves substantially in the 2023-2025 biennium, it is virtually certain that negative trends (i.e. shortage of caregivers, quality of caregivers, etc.), will
