

The United States Attorney's Office for the Western and Eastern Districts of Wisconsin and the Department of Justice's Disability Rights Section, Civil Rights Division are hosting a Voting Listening Session on September 11, 2023, from 2:00 p.m. to 3:30 p.m. via WebEx or in person at the U.S. Attorney's Office for the Eastern District of Wisconsin at 517 E. Wisconsin Ave, Room 630, Milwaukee, Wisconsin.

The purpose of the listening session is to hear from advocates, faith leaders, and individuals about experiences with any barriers faced by individuals with disabilities in the voting process, including in registering to vote, obtaining voting or election information, voting absentee, voting in person, polling place accessibility, or receiving assistance in voting.

These series of events are designed to gain insight from Wisconsin residents on their primary concerns, questions, and ideas regarding the future of Social Security. AARP invites all those interested in this topic and who have a desire to be involved in protecting Social Security to join us as we lay the groundwork for our future efforts.

You are encouraged to join AARP at their nearest listening session where you will have the opportunity to enjoy free food and drinks as they connect with others from their community on this important topic.

AARP WI will be there with information on how Social Security works, how people can maximize their benefit, and how they can fight to



protect Social Security. We will also be looking to attendees to provide their insight as we lay the groundwork for our efforts to ensure that our elected officials here in Wisconsin fight for a robust and healthy Social Security program that is sustainable for many years to come.

In Wisconsin, more than one in five residents receive Social Security benefits. These payments inject more than \$22.2 billion into the state's economy every year. The largest group of beneficiaries in Wisconsin are its 950,000 retired workers, who account for 74.5 percent of all Social Security beneficiaries in the state.

Social Security also lifts more than 264,000 Wisconsinites aged 65 or older out of poverty. In fact, 33.5 percent of this state's residents in this age group would be in poverty if it weren't for their Social Security benefits. That number falls to 6.6 percent when Social Security income is included.

### September 6 webinar available: Children Living in Grandparent-Led and Multigenerational Families: Implications for Policy and Practice

The University of Wisconsin-Madison is hosting a webinar for professionals working with relative caregivers & children.

The number of children living in multigenerational households has been increasing steadily since the 1980s, and as of 2021, more than 10% of children (roughly seven and a half million) share a home with two or more generations. While the stays may be relatively short, overall, about 30% of children will live in a multigenerational or skipped-generation household at some point during their childhood. This is even more



common for children of color and for those whose adult family members are low-income. In this webinar, the panelists will examine the scope of the issue and its implications for child well-being and security, as well as opportunities in policy and practice to support these children and their adult household members.

#### Reminder: September 20 webinar: Expanding Dementia Capability in Indian Country

National Alzheimer's and Dementia Resource Center has announced an "Expanding Dementia Capability in Indian Country: A case example from Inter Tribal Council of Arizona, Inc."

Limited availability of dementia services in Tribal communities has resulted in many community members voicing their concerns about the need for assistance and education. To help fill this void, the Inter Tribal Council of Arizona, Inc. (ITCA) is currently implementing services and supports for people living with dementia and their caregivers through ACL's Alzheimer's Disease Program Initiative (ADPI). The ITCA project is providing dementia specific evidence-based training, community-based education, resources, and music strategies in Tribal communities.

In this webinar, participants will learn how the ITCA ADPI project is empowering Tribal staff and community members to become involved in providing dementia education and awareness in their communities. In addition, the Banner Alzheimer's Institute, a collaborative partner to ITCA, will share information about the Walk with Me music program and how it can be used to increase the quality of life for someone living with dementia. Banner will explain how the Walk with Me CD was adapted to create education that is both experiential and impactful, and how music can be used as an important connection for people living with dementia and their caregivers.

Last month Ingrid Kundinger from the Senior Medicare Patrol (SMP) was interviewed about Medicare scams/fraud related to COVID-19 over-the-counter test kits.

Unfortunately, charges for unwanted COVID-19 tests continue to be an issue and many older adults are not aware of the fraudulent charges until they review their Medicare statements. If someone you know suspects their Medicare number may have been
