Action Alert: Older Americans Act 2024 Federal Funding

Take Action: Contact U.S. Senators Ron Johnson and Tammy Baldwin and your U.S. Representative and tell them what federal funding cuts would mean for your Older Americans Act (OAA) programs and the people you serve. Encourage your board members, advisory council members, volunteers, program participants, and other community partners to do the same! None of the 12 appropriations bills for federal fiscal year (FFY) 2024 that need to be passed by Congress by Oct. 1 to avert a continuing resolution (CR) have been passed by both the House and the Senate.

Congress now has less than one week to avert a shutdown before the government runs out of money (Sept. 30 and the last day of the current FFY). The Senate is not in session Monday of this week, but is scheduled to meet Tuesday night to begin taking votes on the Federal Aviation Administration reauthorization bill. The Senate is expected to try to use this reauthorization bill to also pass a continuing resolution (CR) to keep the government running while Congress continues to negotiate final spending bills for fiscal year (FY) 2024 which begins Oct. 1. This CR is expected to be clean stopgap funding legislation (no other proposals that could threaten its passage) in hopes that the House will agree to vote on it by the end of the week.

Last week, the House majority introduced a CR to keep the federal government running until Oct. 31. The House CR also included an across the board cut of 8% for non-defense discretionary programs (which includes OAA funding). According to a White House press release, an 8% funding cut would lead to 60,000 seniors not being able to receive nutrition services.

Internal disagreements between House Republican leadership and a handful of its members leave the majority without the votes needed to pass even a short-term spending bill in that chamber. Given the content of some of the House CR proposals recently introduced, our national association (USAging) is concerned that even if a CR is passed and a shutdown is averted, the CR may bring its own pain.

Advocates need to urge Congress to pass a clean short-term funding agreement (CR) that protects and increases funding for Older Americans Act (OAA) programs. A government shutdown of any length can cause unnecessary hardship and uncertainty.

Healthy Aging Grants

Earlier this month, Rep. Rozar (R-Marshfield) and Sen. Feyen (R – Fond du Lac) introduced legislation to fund Healthy Aging Grants (AB 418/SB 407). This legislation directs the Department of Health Services (DHS) to allocate a \$378,000 grant in each fiscal year of the 2023-25 fiscal biennium to a private, nonprofit entity that conducts certain activities related to healthy aging, including coordinating the implementation of evidencebased health promotion programs to support healthy aging; serving as a statewide clearinghouse on evidencebased falls injury, disease prevention, self-management, and health promotion programs; providing training and technical assistance to the staff of county departments, administering agencies, and other providers of services to aging populations; and collecting and disseminating information on falls injury, disease prevention, and health promotion in healthy aging populations. Falls are the number one cause of injuries in older adults and are a key driver of emergency department (ED) visits, hospitalizations, and nursing home admissions. One in four older adults has a fall each year and, sadly, Wisconsin has the highest rate of deadly falls in the nation. Yet, there is no state investment in falls prevention. An estimated \$1 billion is spent annually on falls-related health costs in Wisconsin which includes both Medicaid and out-of-pocket expenses. Falls represent an increasing percentage of 911 calls taxing local EMS and emergency department (ED) capacity. Several Wisconsin fire departments have reported the percentage of fall-related calls to be 30-40%.

Launched in 2023, the Falls Free Wisconsin Center, along with community partners statewide, will provide:

- Virtual falls-risk assessments and interactive tools to reduce risk.
- State and local public awareness campaigns to help consumers find and access prevention resources.
- Support for local prevention programs and initiatives.
- Coordination of Wisconsin's statewide falls prevention coalition.
- Support and resources for emergency service and health professionals.
- Sustainability and expansion of Stepping On an evidence-based program shown to reduce falls by 31%. To date, over 21,000 people in Wisconsin have participated in the Stepping On program.

Nearly 95% of older adults have at least one chronic condition such as heart disease, diabetes, or arthritis; 80% have two or more. Ninety percent (90%) of the nation's health care expenditures are for chronic conditions. The direct costs to the Medicaid system are estimated at \$1.15 billion annually in Wisconsin. The **Wisconsin Institute for Healthy Aging (WIHA)** offers physical activity and chronic disease self-management programs taken by over 20,000 people in Wisconsin — that focus on behavior change and are evidence-based to reduce health care utilization, improve outcomes, and reduce the risk of moderate or severe functional limitations.



Falls Free Wisconsin

State investment in Healthy Aging Grants will:

- Ensure the long-term sustainability of the Falls Free Wisconsin Center and expand access to Stepping On and other programs to reach more people, reduce falls and save dollars, and
- Sustain the infrastructure needed to support local program providers and ensure that programs are
 accessible to people throughout the state. Together, we can reduce falls, better manage chronic
 conditions, increase physical activity, and preserve independence all while reducing the burden and
 costs to health care and public safety.

We hope to see this legislation move quickly through the legislature this fall. Stay tuned for updates.

CMS Seeking Comments on Proposed Rule to Establish Minimum Staffing Requirements for Nursing Homes

The Centers for Medicare & Medicaid Services (CMS) is seeking comments on a proposed rule that would establish minimum staffing requirements for nursing homes. Research consistently shows a link between resident safety, care quality, and stable staffing in nursing homes; understaffing contributes to inadequate and unsafe care.



To be assured consideration, comments must be received at one of the addresses provided below, by **November 6, 2023.**

In commenting, refer to **file code CMS–3442–P**. Comments must be submitted in one of the following three ways (please choose only one of the ways listed):

1. *Electronically*. You may submit electronic comments on this regulation to <u>http://www.regulations.gov</u>. Follow the "Submit a comment" instructions.

2. *By regular mail*. You may mail written comments to the following address ONLY: Centers for Medicare & Medicaid Services, Department of Health and Human Services, Attention: CMS–3442–P, P.O. Box 8016, Baltimore, MD 21244–8016.

Please allow sufficient time for mailed comments to be received before the close of the comment period.

Abuse In Later Life Training And Kickoff Event Information for Walworth, Polk, Dunn, and La Crosse Counties

This interactive training event, led by the National Clearinghouse on Abuse in Later Life, is open to front line professionals, supervisors, and agency decision makers from any organization or agency that may have contact with older victims of abuse.

Walworth, Polk, Dunn, and La Crosse Counties received a federal grant through the U.S. Department of Justice's



Office on Violence Against Women to focus on Abuse in Later Life. The program supports a comprehensive approach to addressing abuse in later life, including domestic violence, dating violence, sexual assault, stalking, neglect, abandonment, economic abuse, or willful harm committed against victims who are 50 years of age or older.

The three-year grant program will have a strong focus on the following in Walworth, Polk, Dunn, and La Crosse Counties:

- Providing training and cross training to professionals across the county
- Establishing or enhancing a multi-disciplinary coordinated community response team
- Providing and/or enhancing victim services for victims of abuse in later life
