**Ideas discussed:** (1) Offer a "Prepare to Care" presentation and information specific to this audience (e.g., advance directive planning, etc.) (2) Consider the language being used. For example, "family caregiver does not fit each caregiving situation. (3) Don't give up! Keep trying & reach to underserved populations, and think about population-specific events (e.g., PRIDE, partner with local LBGT community centers, and coalitions, as well as safe spaces like HIV testing clinics). (4) Share with Lynn/Bryn - we can possibly share on social media and/or share in Newsletters. (5) Consider the time that events are offered, a time more convenient for working caregivers might have better outcomes. (6) Do LGBTQIA+ customers prefer a specific gender of a caregiver or someone who has special training? Can this be accommodated? (7) Use Trualta as a resource! Trualta offers a specific toolkit and community chat room specific to LGBTQIA+ individuals.
