#### Need to Know

#### House Committee Passes FY25 Funding Bill with Cuts to OAA

Last week, the full House Appropriations Committee passed the Labor-Health and Human Services-Education (Labor-HHS-Education) appropriations bill. The Labor-HHS-Education bill includes an outline of FY 2025 funding levels for the Older Americans Act (OAA) and other aging service programs. The full House is expected to take up the bill in August.

Funding levels in the bill for the OAA Nutrition programs are far less than what is needed to meet the needs of local programs and older adults who rely on these critical services. The bill reflects a cut of \$16.3 million over FY 2024 funding levels. Additionally, the bill ends funding for the Senior Community Service Employment Program (SCSEP) program and Adult Protective Services (APS).

Though it is unlikely this appropriations bill will be the final bill enacted into law, it does raise serious concerns about the future funding levels for these programs. Our advocacy efforts must continue, as we

work to help legislators understand just how harmful funding cuts will be to local programs in their districts and to the many older adults in need of services.

To address the growing older adult population and existing waiting lists, Meals on Wheels America is advocating for \$1.842 billion for the OAA Nutrition Program in FY 2025. Every August, members of Congress take a summer recess and are back in their home states and district for the month. August is a great time for you to reach out to your federal legislators and invite them to ride along on a home-delivered meal route, visit a congregate dining site, our help to prepare or serve a meal at the dining site. Please consider extending an invitation to your Congressional Representative or Wisconsin's U.S. Senators soon (see <u>Wisconsin Members of the 118th Congress</u> for contact information). The Department of Health Services (DHS) is pleased to announce this grant opportunity to Wisconsin counties interested in developing a

dementia crisis stabilization unit (DCSU). This competitive grant opportunity is intended to provide counties with the opportunity to develop a DCSU that will provide crisis assessment, stabilization, and necessary treatment for individuals for whom the crisis is judged to be significantly related to the person's cognitive issues (suspected or diagnosed dementia) and whose needs cannot be appropriately met with other resources in the region. The goal of a DCSU is to stabilize a dementia-related crisis and return the person to their previous residence or a least restrictive setting within 28 days or less. The grant application is due 5:00 p.m. (central time) on July 29, 2024.
