Need to Know

Reminder: House Labor-HHS Subcommittee Advances FY 2025 Appropriations Bill

Earlier this month, the House Appropriations Committee passed the Labor-Health and Human Services-Education (Labor-HHS) appropriations bill. Details are now available regarding funding numbers for all Older Americans Act (OAA) programs.

Good News: The House bill includes increases over the FY 2024 funding for OAA Title III B – Supportive Services, Title III E – National Family Caregiver Support Program, and Title VI – Native American Nutrition, Supportive and Caregiver Services.

Bad News: The House bill makes significant funding cuts for some programs, including the complete elimination of two programs:

Title C1 and C2 Nutrition Programs

Funding for C1 Congregate Meals was reduced by \$22 million and C2 Home-Delivered Meals funding received a \$15 million cut. These funding cuts bring funding for the Nutrition programs nearly back to FY 2023 funding levels.

Title V Senior Community Service Employment Program (SCSEP)

The SCSEP received no funding under the House Committee bill. Based on an evaluation of the SCSEP that found the program led to unsubsidized employment for less than half of program participant available for employment and even lower rates of unsubsidized employment for participants with a disability and for older adults and participants with lower levels of education.

Adult Protective Services (APS)

The House Committee did not provide any funding for APS. No details were provided as to why this decision was made.

Reminder: DHS seeking input on IRIS program waiver renewal

The Department of Health Services (DHS) is seeking ideas/public input on the Medicaid waiver renewal for the IRIS (Include, Respect, I Self-Direct) program (Wisconsin's long-term care self-directed Medicaid waiver program). According to the most recent IRIS enrollment data - June 2024 Report - of the 26,489 IRIS participants, 6,310 or roughly 24% of all participants are listed in the frail elders (FE) category.

Need to Know

Wellsky Title III data deadline Oct. 18

This year's deadline to enter in Title III services to Wellsky/SAMS AND make sure all client and service data is accurate for the reporting period **October 2023-September 2024** is **October 18th!** For fiscal claim forms, your September (and all prior monthly claims) are due by **November 8th!** This information is then used for the GWAAR region and State of Wisconsin Federal Older American's Act Report.

If, upon reviewing and correcting data, services are removed from Title III to Title VI, NOAA or Family Care, as examples, you must let your fiscal staff know as it will impact your claim forms.

The list of Error and Informational reports to run can be found on the GWAAR Data Management "old" SharePoint Site, along with an instructional guide. We are continuing to work on providing users access to the new GWAAR Partner Resource site.

Stepping On New Facilitator Training Added!

November 18-20 | 8:30 a.m. - 4:00 p.m.

Due to high demand, the Wisconsin Institute for Healthy Aging (WIHA) added another Stepping On Facilitator Training this fall. Now is the time to spread the reach of your Stepping On falls prevention program and train additional facilitators.



Facilitator requirements include:

- Must be a healthcare professional, aging network professional, fitness specialist or other professional that works with older adults.
- Must be employed by or volunteer for a registered program provider.
- Must hold at least one community workshop every 12 months.
- Must identify an eligible co-facilitator.

Stepping On is researched and proven to reduce falls by 31%! This evidence-based falls prevention program helps older adults reduce their risk of falls, improve their ability to safely navigate their environment, and ultimately, increase their quality of life.

The deadline to apply for this training is October 14, 2024. Cost = \$525.00
