In conjunction with the Veteran and their family, the VSDP Care Consultant is responsible for assessing the Veteran's abilities and level of functioning, identifying areas of need and preferences for meeting those needs, developing a care plan to meet the needs; assisting the Veteran and family caregiver with setting up and purchasing goods and services within their individual budget allocation; and assisting the Veteran with monitoring service provision.

Engage Your Representatives to Push OAA Reauthorization Forward!

Last month, the Senate HELP Committee passed the OAA Reauthorization Act of 2024. Our national association of area agencies on aging (USAging) endorsed the bill as it fully or partially incorporates many of their priorities.

A few members of the House have started work on the OAA reauthorization process; however, there is still much work to be done to move this process forward. Our attention must now be focused on the House and their OAA reauthorization process. Members of Congress are at home for August recess, offering the perfect time to reach out to House members.

Reminder: Task Force on the Healthcare Workforce Releases Full Report

On Aug. 19, 2025, the Governor's Task Force on the Healthcare Workforce released its final report and advisory action plan. The advisory action plan outlines solutions to address the state's longstanding healthcare workforce shortages. The taskforce met six times over the course of six months and adopted 10 recommendations with 26 action items representing a variety of policies and programs to address issues including education, training, recruitment, and retention of health care workers.

The advisory action plan:

- Presents a comprehensive analysis of current and future workforce challenges impacting the health care sector.
- Explores educational and training pathways to create a more diverse, equitable, and sustainable workforce. Identifies strategies to improve patient care and alleviate the burden on our health care workforce.
- Recommends solutions, including new policies and programs, modifications to existing programs, and necessary changes to state statutes.

The National Center to Reframe Aging gave a wonderful overview of their tools and resources. In addition, important updates were shared regarding the ARPA D funding extension and reauthorization of the Older Americans Act proposed revision of evidence-based guidelines for III-D funding. GWAAR recently learned

that there has been an extension granted until September 2025 for ARPA B, D & E. At this point, it's important to start spending down your 2024 OAA Title III-D funds.

Over the next few weeks, I will be sending emails to those counties who have 60% or more of their 2024 III-D funds remaining. Please watch the portion of the webinar where Patrick Metz, GWAAR Fiscal Manager, explains this in more detail.
