#### **Reminder: VSDP Care Consultant Employment Opportunity**

The Veteran Self-Directed Program (VSDP) helps Veterans needing assistance choose their own caregivers, services, and supports to be able to safely and successfully remain living in their home. In conjunction with the Veteran and their family, the VSDP Care Consultant is responsible for assessing the Veteran's abilities and level of functioning, identifying areas of need and preferences for meeting those needs, developing a care plan to meet the needs; assisting the Veteran and family caregiver with setting up and purchasing goods and services within their individual budget allocation; and assisting the Veteran with monitoring service provision.

This position requires a significant amount of travel within the North Chicago, Tomah, Madison, Milwaukee, and Minneapolis VAMC catchment areas. Ideal candidate will be located in Southern/Southeastern part of the state (Milwaukee, Waukesha, Jefferson, Green, Rock, Walworth) and/or Dane County area.

# Fiscal Webinar - ARPA C1 and C2 2024 De-Obligation and Re-Obligation Requests, 2025 Budget form Friday, September 13 | 10:00 a.m.

As the deadline for the ARPA C1 and C2 contracts approach (September 30th, 2024), your Aging Unit may have determined underspending or a need for additional funds.

If you have determined that your Aging Unit will need to de-obligate ARPA C1 or C2 funding as your agency is unable to spend the funds by the deadline, please complete the ARPA C1 and C2 2024 De-Obligation and Re-Obligation Requests form on the <u>GWAAR Partner Resources - External</u> Fiscal Resources SharePoint Site by September 30. Some Aging Units may be contacted by GWAAR program or fiscal staff after reviewing their claim expenditures to follow-up on anticipated spending by the deadline to ensure certain contract amounts are being spent or offered to de-obligate.

If you have determined that your Aging Unit could use additional funds within ARPA C1 or C2 funding, please complete the ARPA C1 and C2 2024 De-Obligation and Re-Obligation Requests form on the <u>GWAAR Partner Resources - External</u> Fiscal Resources SharePoint Site by September 30th. Some Aging Units may be contacted by GWAAR program or fiscal staff after reviewing their claim expenditures to follow-up on anticipated spending or review a need for additional funds. Completing this form does not guarantee additional funding will be provided, as that will be determined by available de-obligated funds.

Any re-obligated funds are to be used for January-September 2024 expenses only and must be expensed by the September 2024 Claim form.

#### Reminder: Wellsky Title III data deadline Oct. 18 (RUN 9/17)

This year's deadline to enter in Title III services to Wellsky/SAMS AND make sure all client and service data is accurate for the reporting period **October 2023-September 2024** is **October 18th!** For fiscal claim forms, your September (and all prior monthly claims) are due by **November 8th!** This information is then used for the GWAAR region and State of Wisconsin Federal Older American's Act Report.

If, upon reviewing and correcting data, services are removed from Title III to Title VI, NOAA or Family Care, as examples, you must let your fiscal staff know as it will impact your claim forms.

The list of Error and Informational reports to run can be found on the GWAAR Data Management "old" SharePoint Site, along with an instructional guide. We are continuing to work on providing users access to the new GWAAR Partner Resource site.

The National Center to Reframe Aging gave a wonderful overview of their tools and resources. In addition, important updates were shared regarding the ARPA D funding extension and reauthorization of the Older Americans Act proposed revision of evidence-based guidelines for III-D funding.



GWAAR recently learned that there has been an extension granted until September 2025 for ARPA B, D & E. At this point, it's important to start spending down your 2024 OAA Title III-D funds.

Over the next few weeks, I will be sending emails to those counties who have 60% or more of their 2024 III-D funds remaining. Please watch the portion of the webinar where Patrick Metz, GWAAR Fiscal Manager, explains this in more detail.
