Valentines for Wisconsin Veterans

The Wisconsin Department of Veterans Affairs (WDVA) is asking for help showing veterans how much we appreciate their service and sacrifice by sending Valentine's Day cards to veterans living in WDVA facilities.

In their first year, WDVA received 24,000 Valentines and last year that grew to 28,000. Because of the overwhelming response, WDVA will be able to share valentines with even more veterans by delivering them to three locations in Chippewa Falls, Green Bay, and Union Grove.

The valentines are hand-delivered by staff to the veterans, loved ones, and Gold Star families residing in our veterans facilities. Cards must be mailed no later than January 31, to allow time to be distributed to all WDVA



facilities on February 14. Due to allergies/dietary restrictions, do not include candy, food, or snacks.

State Legislature - 2025-2026

Mon., Jan. 6, 2025, marked the start of the 2025-2026 State Legislature. There are many new faces in the legislature (6 in the Senate and 31 in the Assembly). Given the new members in the legislature, as well as the new district maps, many of you may have new legislators serving you and/or the area you serve. If you are uncertain about who represents you, go to the Wisconsin State Legislature's homepage – https://legis.wisconsin.gov/ and type your home address in the box under, "Who Represents Me?" Need to Know

ARPA Extension contract: now that September claims have been processed, we are able to provide the remaining allocations to the state for GWAAR to receive a new ARPA contract (Oct 2024-Sept 2025). Just as a reminder, this is a new contract not an amended contract extending out the date as before and should be used for expenses from Oct 2024-Dec 2024 for this calendar year, and then Jan 2025-Sept 2025 for expenses in 2025. The allocations will be posted on the Final claim form, until the ARPA funds are available on the claim form Aging Units should report the expenses in Cash Match or using other contract funds on their Oct-Dec claim forms and then adjust as necessary on the Final claim.

NSIP 24-25 contract: GWAAR has received the NSIP contract from the state and will be distributing out Aging Unit contracts shortly. As a reminder, this contract is for the expenses associated with raw food cost only and not the full cost of the meal. The allocations will be posted on the Final claim form, until the NSIP funds are available on the claim form Aging Units should report the expenses in Cash Match or using other contract funds on their Oct-Dec claim forms and then adjust as necessary on the Final claim.

Other updates:

- Report 99 in PeerPlace currently this custom report has not been created in PeerPlace. This will not prevent you from submitting your October claim. We continue to work with BADR and PeerPlace to have this available and will let you know when it is along with providing training on how to run the report.
- If completing a Re-Obligation request, by completing this form you are requesting additional contract funding, if available, which must be spent by Dec. 31, 2024, for expenses from Jan.-Dec. 2024. By completing this form, you understand any requests are not guaranteed and must be claimed by the Final Claim form, due March 5, 2025.

Upcoming:

• The Budget to Actual document will also be forthcoming. This document compares your submitted Final Budget for 2024 against the actual expenses reported. We will host a webinar to assist Aging Unit Fiscal staff in reviewing the information and how to address inconsistencies.
