#### Need to Know

#### **Protect Medicaid**

Aging and disability constituents and other advocates throughout the state and across the country have been contacting Congress to talk about what Medicaid cuts would mean for them, their families, and the workers paid to provide their care. Your calls are making an impact. Congress knows older adults, people living with disabilities and those who care for and about them are watching.

Late last week, <u>media reports</u> said there are some Medicaid cuts many members of Congress support, but your calls are making lawmakers question how other Medicaid cuts will impact the areas they represent. Congress must decide which Medicaid cuts they want to put in or leave out of a bill. They are trying to decide in the next few days. The longer the delay the more likely there is not agreement on what to cut and how much.

Your calls early this week can help them decide NOT to put Medicaid cuts in the bill.

The Wisconsin Board for People with Developmental Disabilities (BPDD) has been collecting feedback from constituents who have called their U.S. Senators and Congressional Representative. #### **Background**

Congress is considering \$2.17 Trillion cuts in federal Medicaid spending (<u>summary</u>, <u>detailed list</u>), which would dramatically reduce the amount of money sent to states. Cuts of this size will impact Wisconsin's state budget, the 1.2 million Wisconsinites who get health and long-term care coverage through <u>programs funded by Medicaid</u>, and the businesses and providers whose salaries and costs are paid for by Medicaid dollars.

National advocates believe these ideas to cut federal Medicaid spending will be part of a budget reconciliation bill and that the bill will move fast. The first steps could move as early as this week. Stay tuned for updates as we learn more.

## **Action Steps you can take today:**

Make three phone calls to your Federal Legislators.

You have three Federal legislators who will make decisions about cuts to Federal Medicaid spending.

- Contact Wisconsin's two U.S. Senators, Sen. Tammy Baldwin (202) 224-5653 and Sen. Ron Johnson (202) 224-5323, and
- Your U.S. Representative (use your ZIP code to Look up your U.S. Representative).

Federal lawmakers need to know how Medicaid helps you, your family, or someone you care about and what it would mean if services and supports were reduced or stopped. Urge your legislators to reject any proposals that reduce federal Medicaid funding.

Consider asking your Federal Legislators what they think about:

- 1. Medicaid cuts (for or against).
- 2. Changing Medicaid into a block grant or per capita cap.
- 3. Lowering the amount of federal money given to states (FMAP) to pay the workers who provide health and long-term care services for people in Wisconsin Medicaid programs.
- 4. Making people in Medicaid prove they are working to get health or long-term care.
- 5. Raising how much it costs to buy a health insurance plan on the Marketplace.
- 6. Stopping payments on spending Congress has approved, including Medicaid, Medicare, Social Security, and disability, aging, and other organizations that serve people in their districts.

Let us know what you hear from federal lawmakers, as it helps advocates know what messages lawmakers need to hear.

The December Claim is due February 5th and needs to include PeerPlace/SAMS data, as this needs to be reviewed by GWAAR staff before the Final claim submission in the event changes need to be addressed. We continue to wait for the ARPA contract and once we have that we'll post the Final Claim – submission deadline to be determined. Reminder this is a new contract, and the funds cannot be used for expenses prior to October 2024.

# Re-Obligations/De-Obligations requested

All agencies looking to request additional funds within the Title III grants or Elder Abuse must complete the online Re-ob/De-ob form by February 17<sup>th</sup>. Any requests after that date will only be considered if there are remaining funds to allocate. If your agency has contract funds remaining above the allowed carryover amount for that grant, please complete the de-obligation portion of this form located within Fiscal Resources library.

# **Budget to Actual**

As this project continues to evolve we will be using the full 2024 calendar year expenses to compare against the 2024 budget by the end of April. As we go into 2025, this comparison will occur earlier in the Fall – stay tuned for more information and training.

# **Intergenerational Connections - Scripps AVID**


Scripps AVID is actively recruiting participants to be matched with students at Miami University starting the first week of March 2025. ScrippsAVID (Arts-based, Virtual, Intergenerational Discovery) is a digital platform designed to foster meaningful connections across generations through creative engagement. It pairs participants, based on availability and generational differences.

Through guided arts-based prompts, participants share music, storytelling, drawing, and conversation, creating opportunities for social connection, creativity, and personal growth. The program is designed to combat loneliness, bridge generational gaps, and build a supportive network where people at different life stages can learn from each other.

# Transit Equity Day 2025: Tuesday, February 4

Transit Equity Day is observed on February 4 to commemorate the life and legacy of Rosa Parks on her birthday and highlights the importance of public transportation and transit equity. Transit Equity Day aims to highlight the need for equitable and accessible public transportation for all.

The observance is an opportunity to advocate for fair transportation policies including such topics as affordable fares, reliable service, improved transit infrastructure and increased transit funding. Transit agencies, organizations, community groups, and activists often use Transit Equity Day to organize events, discussions, and advocacy initiatives aimed at promoting equitable and accessible public transportation.

The goal is to engage the public, policymakers, and stakeholders in efforts to address transit-related disparities and work toward a more just and inclusive transportation system. Check with your local transit agency to see what they have planned to celebrate Transit Equity Day.
