2025 ACL National Survey of Older Americans Act Participants (NSOAAP)

This message is to let our aging network partners know that GWAAR has been selected to participate in the Administration for Community Living's (ACL) *National Survey of Older Americans Act Participants* (NSOAAP). This nationwide survey, in which GWAAR has participated for several years, is conducted by the research firm *Westat*. The NSOAAP survey involves staff from Westat contacting Title III program participants regarding their level of satisfaction with county aging programs accessed over the past 12 months.

Our agency's role involves uploading to Westat's server randomly selected data on a number of OAA program participants who received a Title III service sometime over the past 12 months. Of that set, approximately 120 individuals will be selected and contacted about participating in the survey. Individuals may 'opt out' should they not be interested in participating. Caregivers who are contacted are provided the option of completing an online survey or setting up a time to complete a phone interview. At all points anyone contacted may choose to not complete the survey.

We are honored to again be working on this survey project. Involvement of program clients in completing the survey, "... is vital to providing ACL with representative estimates each year to meet Congressional requirements and support ACL budget requests, which are critical to improving long-term services and supports for all consumers." (ACL notification letter). While the NSOAAP relates specifically to program users of county-based aging programs ACL does collect similar data on nutrition, caregiver, and supportive services provided to Native Americans under Title VI of the Older Americans Act (see: https://agid.acl.gov/release.html).

Evers' budget builds on past efforts to support Wisconsin's mental and behavioral health infrastructure, especially as levels of anxiety, depression, self-harm, and suicidal thoughts among youth across the state continue to rise at concerning rates. This budget makes significant investments in expanding the availability of behavioral health services so Wisconsinites in all stages of life can receive care closer to home.

Need to Know

ACTION ALERT: Ask Your State Legislators to Protect Wisconsin's Caregiver Support Programs

Senate Bill 152 removes income requirements for the Alzheimer's Family and Caregiver Support Program (AFCSP) to align with the federal National Family Caregiver Support Program (NFCSP). Removing income-based eligibility requirements from AFCSP will protect \$3.5 million in annual federal NFCSP funding and ensure support remains accessible to all families.

This legislation (SB 152):

- **Protects Federal Funding:** Secures federal NFCSP dollars vital for caregivers.
- Supports Care at Home: Makes resources like adult day care and home modifications available.
- Reduces Healthcare Costs: Allows individuals to remain at home longer.
- Strengthens Family Support: Ensures no family is left behind.

Take Action: Go to SB 152 to see if your state Senator and Assembly Representative are signed on as sponsors/ cosponsors on the bill. If yes, please send them a message thanking them for their support of family caregivers. If no, contact them and ask them to protect family caregiver programs by signing on in support of SB 152. Let them know how critical family caregiver supports are to you, your family, and/or those you serve.
