Update: U.S. House of Representatives could vote on cuts to Medicaid and SNAP this week

Late Sunday evening, the House Budget Committee passed the budget reconciliation package that includes more than \$700 billion in cuts to Medicaid and \$300 billion in cuts to the Supplemental Nutrition Assistance Program (SNAP). If enacted, this will be the largest cut to Medicaid and SNAP in our history. The House Rules Committee, which decides what bills are sent to the full House for a vote, is now set to begin their markup at 1:00 a.m. (ET) on Wednesday 5/21. Some federal legislators are calling for additional changes to the reconciliation bill as they do not feel the Medicaid cuts are deep enough to pay for the tax cuts in the bill. The Rules Committee could amend the reconciliation bill to include additional cuts or to speed up when some of the changes take place. The bill could also be amended on the House floor. A full House vote could happen by Thurs. (5/22/25)!

There is still time for us to impact what this bill looks like before it becomes a law. If the U.S. House passes a bill with these cuts, the U.S. Senate must also pass an identical bill before it can be sent to the President and signed into law. It Is important for U.S. Senators Ron Johnson and Tammy Baldwin and your U.S. Representative to hear from you about how Medicaid and SNAP (FoodShare in Wisconsin) are critical to you, your family and/or those you serve in your community. Two-thirds of Wisconsinites who use FoodShare are also Medicaid participants.

The proposed federal cuts shift additional Medicaid and SNAP costs onto states to fill in the gaps, resulting in potentially reduced support for older adults, people living with disabilities, and community-based programs.

Take Action: Advocates need to weigh in NOW to push back against these harmful cuts! Proposed Recommendations from Key House Committees Will Harm Older Adults, People Living with Disabilities, and Family Caregivers

Last week key committees in the House of Representatives released recommendations for legislative language that meets their federal savings and spending targets as established in the fiscal year (FY) 2025 budget resolution passed last month.

On Wednesday May 14, the U.S. House Energy and Commerce committee completed its markup proposal which contains more than a dozen provisions that would reduce federal health care spending by \$715 billion, with the funding reductions mostly focused on Medicaid (this would amount to the largest cut to Medicaid in history). A preliminary analysis by the Congressional Budget Office projects these provisions would reduce the federal share of Medicaid spending and lead to 13.7 million people losing their health insurance. Some of the provisions included in the proposal are (this is not a complete list):

 Adding mandatory work and community engagement requirements for individuals ages 19–64 without dependents (with some exceptions that do not appear to include unpaid caregivers),

- Pausing implementation of several final rules published during the Biden Administration, including: the final rule published September 21, 2023, "Streamlining Medicaid; Medicare Savings Program Eligibility Determination and Enrollment" and the May 10, 2024, final rule, "Minimum Staffing Standards for Long Term Care Facilities and Medicaid Institutional Payment Transparency Reporting",
- Increasing the frequency of eligibility redeterminations for certain individuals and adding enrollee address verification policies, and
- Revising policies governing the use of Medicaid provider taxes

The proposed cuts will put increased pressure on state budgets, including Wisconsin's, and make it more difficult for older adults to obtain and retain health and long-term care services needed.

On Wednesday May 14, the U.S. House Committee on Ways and Means passed and advanced its markup of their portion of the FY 2025 reconciliation bill. Their proposal includes several changes that would affect private insurance coverage and Medicare. Some of the provisions in the proposal include:

- Changes to Medicare and the Affordable Care Act (ACA) Marketplace premium tax credit (PTC) eligibility requirements related to immigration status,
- Changes to the ACA PTC eligibility verification checks, and
- Changes to Health Savings Account flexibilities •

The U.S. House Agriculture committee also voted to advance their markup proposal on their portion of the FY 2025 reconciliation bill. Their proposal would create the largest overhaul in decades to the Supplemental Nutrition Assistance Program (SNAP or FoodShare in Wisconsin) and cut as much as \$300 billion in food aid spending. The proposal shifts some of the program costs to states by establishing a cost-sharing approach for states requiring a baseline of 5% of SNAP benefit costs and using a sliding scale based on their payment error rates (note: Wisconsin has one of the lowest payment error rates).

Beginning in fiscal year 2028, states with payment error rates over 6% would begin paying an even higher percent of SNAP costs; the higher the error rate, the higher the percentage of state spending for SNAP benefits ranging from 8 – 25% of the benefit cost.

With the work of these committees now done, the U.S. House Budget Committee is scheduled to begin work on their reconciliation markup Fri., May 16. The release of text and committee markups are key steps in Congress's budget reconciliation process; however, the proposed changes are not yet final, and proposals may change during Senate proceedings.
