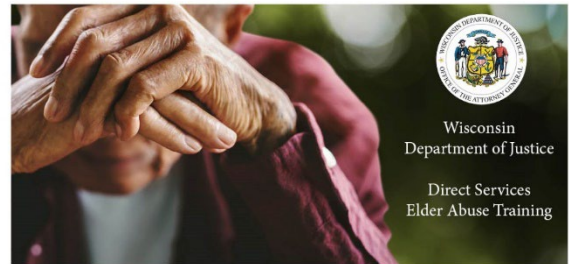

Alzheimer's Family and Caregiver Support Program (AFCSP) - Update

Senate Bill 152/AB 176 removes income requirements for the Alzheimer's Family and Caregiver Support Program (AFCSP) to align with the federal National Family Caregiver Support Program (NFCSP). Removing income-based eligibility requirements from AFCSP will protect \$3.5 million in annual federal NFCSP funding and ensure support remains accessible to all families in need. SB 152 was recommended for passage by the Senate Committee on Health in early May. **The Assembly's Health, Aging and Long-Term Care Committee held a public hearing on AB 176 in mid-May and unanimously (15-0) recommended the bill for passage on June 4. The legislation is now available for scheduling for a vote by the full Assembly and Senate.**

There are 9 state Senators and 25 state Representatives currently signed onto this legislation as a sponsor/cosponsor; that's 34 bipartisan legislators and 26% of the state legislature!

Assisted Living Facility Referral Agencies

AB 255 (<https://docs.legis.wisconsin.gov/2025/proposals/ab255>)/**SB 262** – imposes several requirements for referral agencies related to referring individuals to an assisted living facility in exchange for a fee collected from an assisted living facility. Under the bill, an agency that refers a prospective resident to an

assisted living facility must disclose to the resident any relationship the referral agency has with the assisted living facility, any fee that the assisted living facility will pay to the referral agency, and the fact that the referral agency lists on its website only those assisted living facilities with which the referral agency has a contractual relationship. GWAAR supports the proposed legislation.

State Budget 2025-2027 Update

The State Legislature's Joint Finance Committee (JFC) met three times in executive session to take action on state budget items since completing the round of public hearings in April and is scheduled to meet another two times this week. At their first executive committee meeting on May 8, 2025, in addition to passing the budget motion to remove over 600 items from the Governor's budget (Budget motion #4 -

https://docs.legis.wisconsin.gov/misc/lfb/jfcmotions/2025/2025_05_08/000_budget_motions/motion_4_o_mnibus_budget_motion), they also took up the budget for the Board on Aging and Long Term Care;

unfortunately JFC offered no new items for funding in the BOALTC budget. The Wisconsin Aging Advocacy Network's (WAAN's) remaining budget priorities are in the budgets related to the departments of Justice, Health Services, and Transportation. None of these department budgets are scheduled to be taken up by JFC yet; however, **the state's Legislative Fiscal Bureau did release a new budget paper (#751-Transportation - [Local Transportation Aid](#))** which includes information and budget alternatives related to: Mass Transit and Tier C Operating Assistance; Paratransit Aids; Seniors and Individuals with Disabilities – County Assistance (85.21), Specialized Assistance (85.22), and Tribal Elderly Transportation (85.215); and Employment Transportation Assistance (WETAP). Federal Reconciliation Bill Update

The U.S. House of Representatives narrowly passed their reconciliation bill - **H.R. 1**, titled the "One Big Beautiful Bill Act," by a vote of 215-214, with only Republican votes.

The final bill passed by the House makes the deepest cuts (over the next decade) to Medicaid (over \$800 billion - with 11 million people projected to lose Medicaid coverage and become uninsured) and the Supplemental Nutrition Assistance Program or SNAP (\$300 billion- nearly 30% of the total funding) in the history of both programs. Unless Congress takes some action to lower the deficit, **the bill could also trigger an estimated \$500 billion in cuts to Medicare** (reductions are currently capped at 4% of the annual Medicare budget) over the next decade.

The final House reconciliation bill included several last-minute amendments, including:

- **The timeline for implementing new work requirements for Medicaid recipients has been moved up** View the YouTube video on how the GOP's proposed Medicaid cuts could affect millions of family caregivers - <https://www.youtube.com/watch?app=desktop&v=qL2kZRX7D1U>.
- **Repeal of Medicaid's three-month retroactive coverage period. Retroactive Medicaid coverage under the bill is limited to one month prior to application for coverage.** Under current law, states are required to provide Medicaid coverage for qualified medical expenses incurred for up to 90 days prior to the date of application for coverage.

- **Medicaid expansion would be disincentivized** by capping the total Medicaid payment rate for inpatient hospital and nursing facility services for non-expansion states (like Wis.) at a higher rate (110% vs. 100% of the total published Medicare payment rate) than expansion states. Should non-expansion states ever choose to expand, their ability to pay doctors and hospitals more would be lost.
- **States would be required to pay at least 5% of SNAP (FoodShare in Wis.) benefit costs** starting in 2028. That 5% would increase based on a state's error payment rate based on a sliding scale (up to 25% of the benefit cost). Currently, the federal government pays 100% of SNAP benefits and 50% of the administrative costs (states pay the other 50% of costs to administer the program). In addition to shifting a portion of benefit costs to states, **the bill also increases the state administrative cost-share to 75%. The bill also expands work requirements by providing new paperwork to prove that participants are working, this includes increasing the requirement to include adults aged 54 to 65 years old. The Wis. Department of Health Services calculates that these changes to SNAP will have a fiscal impact for Wisconsin of \$314 million.**

Two-thirds of the people who use SNAP/Foodshare in Wisconsin are also Medicaid participants.

The Senate has now taken up the reconciliation bill and is messaging that there will be changes to the House bill in order to receive the votes needed to get it passed. Their goal is to have the final bill to the President by July 4. The bill only requires a majority vote. **The next two weeks will be critical to push back on cuts to Medicaid and SNAP**, as Majority Leader John Thune (R-SD) has announced his intention to move quickly to pass a bill out of the Senate.

Take Action: Senators Baldwin and Johnson need to hear from Wisconsinites about how these cuts and changes will impact you, your family, and/or your community members.

As we approach World Elder Abuse Awareness Day some data to share below:

5 million or 1 in 10, Americans age 60 plus experience some type of abuse annually. However, only 1 in 24 cases are reported. In 60% of the cases the abuser is a family member; two-thirds are adult children or spouses. Elder abuse victims have a 300% higher risk of death. The financial impact, 28 billion in losses reported last year. Anyone can report elder abuse concerns to your local Adult Protective Services agency. The reporter's name is kept strictly confidential.

We encourage agencies and consumers to join the elder abuse network in Wisconsin in recognizing World Elder Abuse Awareness Day (WEAAD) on June 15. 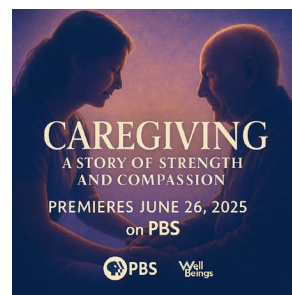

New! High-Level Evidence-Based Program in Wisconsin

A new evidence-based health promotion program has been added to the list of OAA Title III-D eligible programs in Wisconsin. Vivo is a online strength training program for older adults.

Conducted in small, interactive Zoom classes led by certified trainers, Vivo focuses on enhancing strength, balance, and cognitive function. Each class is limited to 8-12 participants, ensuring personalized attention and real-time feedback.

The program begins with individual assessments to establish baselines, allowing for customized exercise modifications suitable for all fitness levels, including those with mobility challenges or recovering from injuries. Over time, participants have reported significant improvements in muscle strength, endurance, agility, and overall quality of life.

Beyond physical benefits, Vivo fosters a sense of community and accountability, which are vital for sustained behavioral change and mental well-being.
