The state legislature's Joint Finance Committee (JFC) is scheduled to take action on the Dept. of Justice (DOJ) budget on Thursday (6/19) afternoon! Now is the time to contact your state Senator or Assembly Representative!

The Wisconsin Aging Advocacy Network (WAAN) is recommending an annual increase of \$350,000 in the 2025-2027 state budget for "Grants for Protection of Elders" to support current programs that no longer have federal funding options. In the past, these grants were used to successfully provide training for professionals to help them detect and prevent elder abuse, hold offenders accountable for abuse and exploitation, and support victims of abuse. Without state funding to continue these grants, this work cannot continue. Funding for grants was not included in the Governor's budget and therefore the Legislative Fiscal Bureau has not created a budget paper for this program. **This does NOT mean JFC can't increase the funding without a budget paper.** 

Call to Action: Your voice is needed now! Ask your State Senator & State Assembly Representative to support an annual increase of \$350,000 in the 2025-2027 state budget for "Grants for Protection of Elders."

If your legislator(s) is a member of the <u>Joint Finance Committee</u> ask him/her to support these priorities when they vote on Thursday. If your legislator(s) is not a member of the Joint Finance Committee (JFC) ask him/her to ask their colleague/budget buddy on the JFC to support this essential funding. (\*Any paid staff concerned about lobbying restrictions – you may still contact your own representatives, as well as legislators who represent constituents in the area you serve, to discuss these important priorities and how they impact your community and those you serve without violating lobby laws [avoid asking for support or opposition of the specific budget proposals] and of course you may contact your own legislators about anything when you are off duty and only representing yourself.

### State Budget 2025-2027 Update

The State Legislature's Joint Finance Committee (JFC) has now met five times in executive session to take action on state budget items since completing the round of public hearings in April. They are scheduled to meet again on 6/17/25. To date, the committee has not yet taken up the Departments of Health Services, Justice, or Transportation; these are the department budgets in which the remaining Wisconsin Aging Advocacy Network (WAAN) budget priorities would be addressed. In addition to the transportation budget paper links shared last week, the Legislative Fiscal Bureau has now also released budget papers for the Department of Health Services.

# Impact of the House Reconciliation Bill on Wisconsinites' Health Care Coverage

Last week, the Wis. Department of Health Services (DHS) released a detailed analysis providing additional information regarding the impact the house-passed reconciliation budget would have on the health care coverage of Wisconsinites if it were passed into law.

Using data from the federal Joint Economic Committee (JEC), DHS determined that provisions in the bill, such as work reporting requirements, would put approximately 63,000 Wisconsinites at high risk of losing health insurance and cost the state's taxpayers more than \$74 million annually.

The DHS analysis also identifies additional impacts of the Medicaid and Affordable Care Act (ACA) provisions in the budget reconciliation bill which would significantly and negatively impact Wisconsinites, including:

- Making health insurance unaffordable to more than 110,000 Wisconsin families who access coverage through the health insurance marketplace,
- Increasing medical debt and uncompensated care,

- Preventing Wisconsin from drawing down more federal Medicaid funding to innovate its Medicaid • programs, and
- Limiting Wisconsin's ability to support hospital and provider pay •

Senate leadership is working to amend the House reconciliation bill and rush it to the Senate floor before the end of the month! Congress would like the bill to be completed by July 4, 2025. Given the speed at which the Senate may take action on the bill, contact with Senators Tammy Baldwin and Ron Johnson is needed NOW.

Take Action: Senators Baldwin and Johnson need to hear from Wisconsinites about how these cuts and changes will impact you, your family, and/or your community members. Urge them to reject the bill's cuts to Medicaid and SNAP that would see millions lose health and nutrition coverage.

Help us prevent elder abuse and build strong supports for our communities as we age.

It is estimated that 5 million Americans, or 1 in 10 older adults in the community experience abuse every year. Let's work to keep everyone safe as we age. If you have seen concerning changes in behaviors in an older adult and suspect they may be experiencing abuse, neglect, or financial exploitation you can call your County Adult Protective Services (APS) Unit.

Warning signs could include:

- Isolation from family and friends
- Changes in banking patterns or financial management
- Lack of medical follow up or unsanitary hygiene or home condition

Reports are confidential and APS professionals will follow up with linking older adults with services or protection to help them remain safe and supported.

### Reminder: New! High-Level Evidence-Based Program in Wisconsin

A new evidence-based health promotion program has been added to the list of OAA Title III-D eligible programs in Wisconsin. Vivo is a online strength training program for older adults.

Conducted in small, interactive Zoom classes led by certified trainers, Vivo focuses on enhancing strength, balance, and cognitive function. Each class is limited to 8-12 participants, ensuring personalized attention and real-time feedback.



The program begins with individual assessments to establish baselines, allowing for customized exercise modifications suitable for all fitness levels, including mobility challenges or recovering from injuries. Over time, participants report improvements in muscle strength, endurance, agility, and overall quality of life.

Beyond physical benefits, Vivo fosters a sense of community and accountability, which are vital for sustained behavioral change and mental well-being.
