Alzheimer's Family and Caregiver Support Program (AFCSP) Update

Senate Passes Senate Bill 152 and Assembly Scheduled to Vote on June 24!

Last week, the full Senate passed Senate Bill 152 (SB 152) on a voice vote. Senate Bill 152/Assembly Bill (AB) 176 removes income requirements for the Alzheimer's Family and Caregiver Support Program (AFCSP) to align with the federal National Family Caregiver Support Program (NFCSP). Removing income-based eligibility requirements from AFCSP will protect \$3.5 million in annual federal NFCSP funding and ensure support remains accessible to all families. The Assembly's Health, Aging and Long-Term Care Committee held a public hearing on the companion bill (AB 176) in mid-May and unanimously (15-0) recommended the bill for passage on June 4. Since its passage, SB 152 has been messaged to the Assembly. This legislation is scheduled for a vote of the full Assembly on Tues., June 24! If passed in the Assembly, the legislation would be advanced to the Governor to be signed into law!

There are currently 13 state Senators and 26 state Representatives signed onto this legislation as a sponsor/cosponsor; that is 39 bipartisan legislators and 30% of the state legislature!

State Budget 2025-2027 Update

After six executive Committee meetings to take action on parts of the state budget, the state legislature's Joint Finance Committee (JFC) is now at a standstill. The committee's meeting on June 19, at which they planned to take action on the Department of Justice budget and other portions of the state budget, was cancelled shortly before it was scheduled to start.

Over the past several weeks, Assembly and Senate Republican leadership have been meeting with Gov. Evers to negotiate budget priorities. Unfortunately, the negotiations reached an impasse with Senate Republicans expressing concern that budget discussions were heading in a direction they could not support. Senate Republicans are pushing for tougher spending decisions.

It is unclear when budget negotiations or JFC action on budget items will resume. The Wisconsin Aging Advocacy Network (WAAN) has budget priorities remaining in the departments of Health Services, Justice, and Transportation, none of which have yet come before the JFC. The state fiscal year ends on June 30, 2025. If the 2025-2027 budget is not passed by the end of June, state operations and funded programs will continue at prior year funding levels. Stay tuned for additional state budget updates and actions alerts.

Federal: Senate Releases Reconciliation Bill, Moves Quickly to Pass Medicaid and SNAP

Last week, the Senate Agriculture and Finance Committees released details of their draft budget reconciliation bill. The Senate Agriculture Committee's SNAP (FoodShare in Wis.) provisions mostly mirror

the House-passed bill (HR 1) and so still pose serious threats to millions. The Senate Finance Committee's Medicaid proposal, which was expected to lessen the risk of losing coverage, instead poses even harsher Medicaid provisions than the House bill.

Several changes have been identified in the Senate Medicaid reconciliation provisions, including lowering the maximum provider tax rate allowed (in Medicaid expansion states [Wis. is not an expansion state]) and implementing stricter Medicaid work requirements. **The Senate Finance committee's proposal extends Medicaid work requirements to adults with children ages 14 and older** (the House proposal exempted all parents and caretakers from work requirements) requiring them to work or volunteer at least 80 hours a month to qualify for Medicaid.

The Senate reconciliation bill also Blocks Medicaid coverage for certain documented immigrants who have been granted humanitarian protection in the United States. This provision would prevent lawfully residing and documented immigrants from receiving health care coverage. Like the House bill, the Senate bill also prohibits federal implementation of CMS' final rule that reduces barriers for Medicare beneficiaries in Medicare Savings Programs.

Like the House version, the Senate proposal would result in the largest cuts to Medicaid in the history of the program, higher premium costs for ACA marketplace enrollees, significant coverage losses, more uncompensated care for health care providers, and strains on state budgets.

With the Senate text now available, committees can begin the "Byrd Bath" process where the Senate parliamentarian reviews and assesses whether various provisions of the bill are compliant with the purpose of reconciliation and a committee's directive, and if not, remove any noncompliant provisions from the reconciliation bill. The Parliamentarian's rulings are expected to be released by the middle of this week.

Senate leadership is hoping to rush their reconciliation bill to the Senate floor before the end of the month! Congress would like the bill to be completed by July 4, 2025. This leaves only a few days to advocate and prevent these dangerous proposals from becoming law. Engaging with Wisconsin's U.S. Senators Tammy Baldwin and Ron Johnson this week is critical to ensure they understand the harmful cuts in the reconciliation bill and how they will impact the communities you serve.
