- New opportunity to better align year-end fiscal reporting with the GEARS report. (GEARS is the final state report composed of monthly claims and PeerPlace data.)
 - Improved PeerPlace **reporting categories** that better match NFCSP and end-of-year fiscal reports
 - July's GWAAR AFCSP claim will include **two additional columns**
 - For agencies contracting directly with the State for AFCSP: **six-month report** due
