

Volunteer Driver Program/Volunteer Driver Stories Still Needed

GWAAR and the Wisconsin Aging Advocacy Network (WAAN) are collaborating with legislators to create legislation to protect volunteer drivers from denial of insurance coverage or higher insurance premiums, solely because they are volunteer drivers. Interest in this issue has been expressed by Sen. James (R-Thorp) who serves Senate Dist. 23. His office has drafted legislation to protect volunteer drivers, and we are urging him to put the bill out for co-sponsorship soon. Interest has also been expressed by Rep. Snyder (R-Weston) serving Assembly Dist. 85 and chair of the new Speaker's Task Force on Elder Services. One of the ways we can demonstrate strong support for volunteer driver programs and drivers is through constituent stories! We are grateful to the few people who submitted stories and need more.

Please help us distribute the <u>story collection survey link</u> below and encourage more people to participate. Stories are needed from volunteer program administrators, volunteer drivers, volunteer driver program passengers, individuals with unmet transportation needs, and caregivers of people who use volunteer driver programs or need transportation services. Speaker's Task Force on Elder Services Update

The State Assembly Speaker's Task Force on Elder Services is set to begin meeting soon. The task force's first hearing (https://docs.legis.wisconsin.gov/raw/cid/1950205) is scheduled for Thurs., Oct. 30th from 10 a.m. to noon at the State Capitol in Rm. 300 Northeast. This first "informational hearing" is for "invited speakers only" and will focus on scams targeting older people. The hearing will be open for the public to attend (but not testify) and may be aired on WisconsinEye (though it is not currently scheduled as of 10-27-25). The invited speakers include:

Additional hearings are anticipated to be scheduled in Wausau, La Crosse, and another one in Madison.

The task force plans to identify ways to improve the quality of life for older Wisconsinites and will focus specifically on programs, services, and policies that help older people maintain independence in their own homes, encourage social interaction and community engagement to combat isolation and loneliness, prioritize physical wellbeing and financial independence, and prevent elder financial exploitation. They intend to wrap up their work by the end of the calendar year. As specific dates, times, and locations are confirmed, we will share them broadly. It is important for the task force to hear from older people, caregivers, and aging network professionals and board members around the state regarding the programs and services that are successfully helping people to remain living at home, as well as the challenges older people face as they plan to continue living in their homes. If your Assembly Representative is serving on the task force, please reach out and congratulate them on their appointment and let them know you/your agency are available to serve as a resource to them.

SB 578 – Patient's Representative Legislation (Next of Kin) https://docs.legis.wisconsin.gov/2025/proposals/sb578

The Wisconsin Hospital Association is working with legislators again this session to pass legislation that creates "Patient Representatives" with the authority to consent to admissions to certain health care facilities without requiring a petition for guardianship or protective placement. This legislation is similar, but not identical to, Assembly Bill 1088 which was introduced last session; opposed by GWAAR and other aging, disability, and legal advocates; and failed to pass in the Senate before the session ended.

SB 578 was introduced on Oct. 24, 2025 and referred to the Senate Health Committee (https://docs.legis.wisconsin.gov/2025/committees/senate/2966). GWAAR and other aging, disability, and legal advocates are opposing this legislation as we feel this legislation creates risk for patients and family members, has legal and operational issues, and does not resolve the issue it was designed to address (quick transition of hospitalized patients who have become incapacitated to make health care decisions, are medically ready to be discharged, and do not have a Power of Attorney for Health Care [POAHC). This legislation circumvents the Wisconsin statutes and regulations specifically designed to safeguard the rights of individuals by giving "hospital appointed patient representatives" more authority than that given by an adult (via their POAHC documents) to their personally selected health care agent(s), and with no required court oversight. This legislation ignores the already existing process for obtaining a temporary guardian in Wisconsin, which would allow a decision-maker to be put in place much quicker than the permanent guardianship process, and provides court-oversight and timelines for consideration of permanent guardianship, if needed.

This legislation may be scheduled for a hearing soon by the Senate Health Committee or may be taken up by the new Assembly Speaker's Task Force on Elder Services which begins its work this week. Stay tuned for talking points and action alerts.

FoodShare (SNAP) Update

As we head into the fourth week of the government shutdown, no Federal government funding deal has yet to be passed and negotiations on a potential short-term funding bill remain at a standstill in Congress. As we move ever closer to Nov. 21, the date the House passed continuing resolution (CR) set as how long the Federal government would have been funded (at FY 2025 levels), it is increasingly likely that an additional CR will be needed as Congress will need more time to pass all the FY 2026 spending bills.

Pressure on Congress to reopen the government continues to grow; if no spending package passes by Nov. 1, there will not be enough funding for the Supplemental Nutrition Assistance Program (SNAP) or FoodShare benefits in Wisconsin, to provide benefits in November. SNAP/FoodShare benefits are 100 percent funded by the federal government, and therefore, the federal government shutdown must end before members can begin getting benefits again.

This means FoodShare members will not get their monthly benefits on time in November. When the government reopens and federal funding for FoodShare is again available, work will begin quickly to start issuing benefits as soon as possible. Although no November benefits will be issued, FoodShare members may continue to use any benefits currently on their QUEST card. Benefits that are already on members' cards will not be removed because of the shutdown and members can continue to use their current benefits, if any, during the shutdown.

A Senate Republican introduced a bill to fund SNAP benefits for the duration of the shutdown, but Republican leadership has yet to endorse the bill, and Democrats have signaled they will not support funding bills without a fix for the Affordable Care Act premium tax credits at the heart of the shutdown debate. Additionally, Democrats and Republicans introduced bills to pay federal workers during the shutdown and prevent mass firings, but these solutions were rejected by the Senate.

According to the USDA, they are not legally able to use their contingency funds to cover regular benefits. Additionally, the USDA indicated that because SNAP benefits are fully Federally funded, there is no provision or allowance under current law for States to cover the cost of benefits and later be reimbursed.



Reminder: OAA Title III-B Legal Services Notice of Award

Following a comprehensive review and scoring process, Legal Action of Wisconsin Inc. has been awarded the OAA Title III-B Legal Services funding. As part of their proposal, they will be coordinating with Judicare to provide services to the Northern Wisconsin counties and 11 tribes. The contract period will begin on January 1, 2026; it is a one-year contract with the option for four one-year extensions.

As a contracted OAA Title III-B legal services provider, Legal Action of Wisconsin Inc., will be expected to:

- Deliver legal assistance to individuals age 60 and older, with no income or asset test;
- Provide services that address priority legal issues affecting the economic and personal independence of older adults;
- Offer participants to make a voluntary contribution, as required under the Older Americans Act.

The award is contingent upon successful execution of the contract and continued compliance with all federal and state guidelines, OAA provisions, and GWAAR policies.

Support Needed: Protect Wisconsin's Volunteer Drivers Organizational Sign-On Opportunity – LRB-4850

Volunteer drivers provide thousands of essential rides each year for older adults, people with disabilities, and others who can't drive—connecting them to medical care, groceries, and community life.

Unfortunately, many are losing insurance coverage or facing steep rate increases simply for volunteering. Some insurers classify mileage reimbursement as "commercial activity," even when volunteers receive no pay.

We're excited to share that Senator Jesse James is preparing to introduce LRB-4850, a proposal to protect volunteer drivers from unfair auto insurance treatment. This bill ensures insurers cannot cancel, deny, or raise rates solely because someone volunteers their time to transport others. To support LRB-4850, we're circulating a statewide sign-on letter urging Wisconsin legislators to pass common-sense protections for volunteer drivers. LRB-4850:

- Defines "Volunteer Driver" as an individual who, without compensation other than reimbursement for actual expenses, provides transportation under the direction, sponsorship, or supervision of a qualifying entity (such as a governmental or charitable organization).
- Prohibits insurers from canceling, refusing to issue, refusing to renew, or increasing premiums for automobile insurance solely because the policyholder is a volunteer driver.
