#### Speaker's Task Force on Elder Services

The Wisconsin State Legislature's Speaker's Task Force on Elder Services, created last September to identify ways to improve the quality of life for older Wisconsinites, released their final report on Mon., January 22, 2026 - <https://bit.ly/4qDyZCz>

On January 30, 2026, all six bills in the Task Force's legislative package were introduced in the legislature:

- **AB-968** Crypto Kiosks (Snyder, Patrick) Virtual currency kiosks. *Referred to Assembly Committee on Financial Institutions*

## Caregiver Designation Legislation Update (AB 798/SB 795)

In late December 2025, the Caregiver Designation legislation (AB 798/SB 795) was formally introduced.

In the 2023-2025 legislative session, Wisconsin created a process that offers people the option to have emergency contact information included in their electronic record when applying for or renewing their driver's license, learner's permit, or state identification ([Wisconsin Department of Transportation Emergency contact: <https://bit.ly/3O44yqG>](https://bit.ly/3O44yqG)). The Caregiver Designation legislation builds upon the emergency contact information process by also providing for an option for people to designate themselves as the primary caregiver for up to three people in their electronic record.

On Tues., Jan. 20, 2026, the Senate Committee on Transportation and Local Government held a hearing on SB 795. GWAAR provided [testimony in support of the bill: <https://gwaar.org/api/cms/viewFile/id/2008886>](https://gwaar.org/api/cms/viewFile/id/2008886). This common-sense legislation linking care-recipient contact information to a driver's license or state ID, helps to prevent crisis situations where a person with complex needs might go for hours or even days without care. **The Assembly Transportation Committee scheduled a public hearing on Tues., Feb. 3.** The next step is getting the Assembly and Senate Committee to vote on this important constituent-informed legislation soon so it can be moved to the full Senate and Assembly. Let's get this legislation signed into law this session!

## Memory Care Designation Legislation Introduced!

## Ask Your State Senator and Representative to Support Funding Request for FoodShare

*Action is needed now to ensure that Wisconsinites continue to have access to food assistance.*

The [Supplemental Nutrition Assistance Program](#) (SNAP), known in Wisconsin as [FoodShare](#), is jointly run by federal, state, and local governments with the goal of stopping hunger across the country.

In Wisconsin, the Department of Health Services (DHS) administers this program in partnership with county governments. SNAP provides nearly 700,000 Wisconsinites, including older people, people living with disabilities, children, and families, with basic food necessities.

On July 4, 2025, the President signed the 'One Big Beautiful Bill Act' (OBBA) into law. This Act included several significant changes to SNAP, including:

- **Cuts to the federal administrative cost share** from 50% to 25%. Starting October 1, 2026, the Wisconsin DHS and counties will have to cover 75% of the program's administrative costs (previously set at 50%). **\$32.4 million in additional state funding is needed to cover the increase in the state administrative cost share to 75%.**

- **Expanding work requirements** to include adults through age 64 (previously work requirements applied to adults ages 54 and under who didn't have a child under age 18 living in their home). Approximately 43,700 Wisconsinites will be subject to these new requirements with about half at immediate, high risk of losing benefits. **\$20.7 million in state funding is needed for the potential FoodShare Employment and Training (FSET) program participation increase due to more members subject to federal work requirements.**
- **Potential Benefits Cost Share for States.** Beginning in October 2025, the state faces increased costs to Wisconsin taxpayers to either (1) **achieve a very low error rate (\$16.1 million in state funding is needed for 56 new DHS staff and county quality control positions to achieve and maintain an error rate below 6%)** OR, (2) for the first time in SNAP's 80-year history, **cover 5-15% of SNAP benefit costs** depending on the state's error rate (this requirement could cost Wisconsin taxpayers up to \$205.5 million in penalty fees every year).

**State and county budgets are insufficient to cover the increased costs and reduction in federal funding.**

Wis. DHS asked the Legislature for \$69.2 million in state funding to help Wisconsin comply with new federal requirements. We are nearing the end of the current legislative session, so time is of the essence for the legislature to move forward with this request to protect critical food assistance and save Wisconsin taxpayers up to 205.5 million dollars in penalty fees annually.

**Take Action: It is important for state lawmakers to know what it would mean if FoodShare benefits were delayed, reduced, or went away.** Share the importance of this program for you, your family, community members you serve, and others. **Federal Fiscal Year (FFY) 2026 Funding Delay**

**Update as of 2 p.m., Feb. 3: The House approved the appropriations package and it is headed to the president's desk.**

On Jan. 30, the Senate voted overwhelmingly to pass a major funding package consisting of five regular appropriations bills (including the departments of Defense, State, Treasury, Health and Human Services [HHS], Housing and Urban Development and Labor) for FFY 2026 and a two-week stopgap measure for the Department of Homeland Security (DHS). The Labor/HHS portion of the funding package includes funding for the Older Americans Act (OAA) and other aging services. The Senate's funding package is not identical to the package passed earlier by the House. House members are not scheduled to return until Mon., Feb. 2, so it was impossible to avoid a partial government shutdown (the current continuing resolution (CR) expired at midnight on 1/30).

Initially, it was hoped that the House could end the partial government shutdown on its first day back in session; however, Democrats are opposing attempts to fast-track the funding package (a process that requires a two-thirds vote in the House), so the shutdown is now poised to last until at least Tuesday, Feb. 3. Once the package is passed in the House and signed into law by the President, all parts of the government except the Department of Homeland Security (DHS) will be funded through the rest of the fiscal year which runs through Sept. 30. 



## \*\*2026 Draft Budget\*\*

Due to upcoming changes taking effect in 2026 we have yet to post the 2026 Draft Budget. Once we have solidified the changes, we will update the form and inform Aging Directors and Fiscal staff of the posting. GWAAR Fiscal will also hold a webinar to inform Aging Unit staff of these changes and a review of instructions to complete the budget, waiver, and transfer requests. In the meantime, we have received the estimated allocations and have posted them in the Fiscal Resources library under Budget.

## \*\*2026 Claim Form\*\*

GWAAR Fiscal will be updating the 2026 Claim Form with the 2026 allocations and changes to reporting requirements. We plan to have the form posted by late February. We will be hosting a webinar, date/time TBD, to review the updates and respond to questions.

## **\*\*Updated Registration and Intake Forms\*\***

The 2026 Client Registration and Intake forms have been updated and posted in the Data Management library. The following changes were made: Gender - open option, Poverty Level - updated, Race – Asian American added and some minor language changes were made in the privacy statement.
