#### **Speaker's Task Force on Elder Services – Companion Bills Released**

The Assembly's Speaker's Task Force on Elder Services, created last September to identify ways to improve the quality of life for older Wisconsinites, released their final report on Mon., January 22, 2026 - <https://legis.wisconsin.gov/assembly/85/snyder/media/vgratypa/elder-service-final-task-force-report.pdf>.

On January 30, 2026, all six bills included in the Task Force's legislative package were introduced in the Assembly. Last Fri. (2/06/26), the Senate companion bills for this legislative package were released. More details on these bills are available in the February 3 GWAAR newsletter:

**On Wed., Feb. 11, the Assembly's Health, Aging and Long-Term Care Committee will meet in executive session to vote on AB 969, AB 970, AB 971, and AB 973.**

Time is of the essence, if you have not yet reached out to your state Representative and Senator on bills in this package of importance to you and those you serve, please do so now! The Assembly's last day in session is expected to be next week (2/19) and the Senate will wrap up in March, so bills legislators hope to pass yet this session are being fast-tracked.

**Take Action:** Contact your State Senator and State Representative TODAY to share with them how bills in the Elder Services Task Force package would impact you, others you care about, and/or people in your community.

## **Caregiver Designation Legislation Update (AB 798/SB 795)**

In late December 2025, the Caregiver Designation legislation (AB 798/SB 795) was formally introduced. In the 2023-2025 legislative session, Wisconsin created a process that offers people the option to have emergency contact information included in their electronic record when applying for or renewing their driver's license, learner's permit, or state identification ([Wisconsin Department of Transportation Emergency contact: https://bit.ly/3O44yqG](https://bit.ly/3O44yqG)). The Caregiver Designation legislation builds upon the emergency contact information process by also providing for an option for people to designate themselves as the primary caregiver for up to three people in their electronic record.

## **Memory Care Designation Legislation: Senate Companion Bill Introduced!**

AB-984 Memory Care legislation creating requirements for the use of a "memory care designation" by community-based residential facilities was introduced on Jan. 30, 2026; just in time for advocates participating in the Alzheimer's Advocacy Day at the State Capitol on Feb. 3 to share why this legislation is so important to the safety and care of individuals living with dementia.

## **Ask Your State Senator and Representative to Support Funding Request for FoodShare**

Action is needed now to ensure that Wisconsinites continue to have access to food assistance.

The Supplemental Nutrition Assistance Program (SNAP), known in Wisconsin as FoodShare, is jointly run by federal, state, and local governments with the goal of stopping hunger across the country. In Wisconsin, the Department of Health Services (DHS) administers this program in partnership with county governments. SNAP provides nearly 700,000 Wisconsinites, including older people, people living with disabilities, children, and families, with basic food necessities.

A new federal law passed last summer included several significant changes to SNAP, including:

- Cuts to the federal administrative cost share
- Expanding work requirements
- Potential Benefits Cost Share for States

State and county budgets are insufficient to cover the increased costs and reduction in federal funding.

**Take Action:** It is important for state lawmakers to know what it would mean if FoodShare benefits were delayed, reduced, or went away. Share the importance of this program for you, your family, community members you serve, and others. ## **Save the Date: WAAN 2026 Aging Advocacy Day of Action**

Mark your calendars, on Wed., May 6, 2026, the Wisconsin Aging Advocacy Network (WAAN) will host a "Day of Action" including a virtual training followed by an online campaign. ### **Federal Fiscal Year (FFY) 2026 Budget Signed into Law**

President Trump signed the Consolidated Appropriations Act, 2026 on February 3, 2026, enacting the fiscal year 2026 Labor, Health and Human Services (HHS), and Education funding bill. The legislation provides approximately \$221 billion in total funding, including \$116.6 billion in discretionary funding for HHS (where the Older Americans Act and other aging service programs are funded) for the rest of FY 2026, which runs through September 30. 

Thursday, March 5 | The Edgewater Hotel, Madison





### \*\*Updated Registration and Intake Forms\*\*

The 2026 Client Registration and Intake forms have been updated and posted in the Data Management library.

### \*\*GWAAR 2025 Final Claim Form\*\*

Allocations have been updated to reflect the remaining transfer funds and final end-of-year allocation adjustments. As GWAAR currently does not have the NSIP and SPAP contracts from the State, those allocations will not be available until 2026. The Final Claim form, and any outstanding claims, are **due March 5**. Reminder that January through December, plus a Final claim, must be submitted – 13 in total. Agencies must continue to report any funds used to pay for Aging services even if you have fully expended contract dollars or met your Match requirement.

### \*\*End of Year Re-obligation requests\*\*

We have posted the 2025 Re-obligation Request Form (link located in Fiscal Resources library). This form is to be completed to submit a Re-Obligation request for any of the following contracts held with GWAAR: Title III B, C1, C2, D, E, SSCS, EBS, Elder Abuse and/or AFCSP. Please complete this by **February 20, 2026**.


